- Thank you to the E-Board members who have submitted their *Goals, Plans for the 1st half of the Year and Reports*. Soror YaTonya will follow up with Soror Sonya to determine who has not met those obligations in order to follow up with individuals in an offline conversation. Visibility into the plans that the leaders have now will make it easier to resolve conflicts, now; therefore, if thoughtful conversations with committees regarding the goals, visions and activities in mind have not occurred, it will be difficult for Soror YaTonya to approve the request for an activity.
- Chapter meeting attire: business attire pink; business attire with African accents.
- Seating at Chapter Meeting and Arrival Times: Executive Board will sit together to the left of the dais/stage. Because of the two pre-sorority sessions, E-Board members are asked to arrive between 8:30 a.m. and 8:45 a.m. (new building, security screening, etc.) Soror Hilary was asked to have two members of the Philacter Team on post beginning at 8:30 a.m. at Hall A for the first pre-sorority meeting LD activity. The doors to Hall B should be closed. No one should enter Hall B until at the earliest 9:10 a.m. Two additional members

of the Philacter team are needed on post at Hall B where the Protocol pre-sorority event and chapter meeting will occur.

- If you have a speaking role at the meeting, it is critical that you follow the agenda closely so that the momentum of the meeting flows with one speaker coming onstage immediately after the previous one.
- We have to exit the building by 1:00 p.m. We are paying for the building and have to honor our contract. Goal is to conclude at 12:30 p.m. in order to use the remaining 30 minutes to conclude all activities including breakdown and packing up of materials.
- Sorors have been sending various reports to Soror YaTonya who receives so many emails. In the interest of ensuring that all parties receive the reports in a timely basis, she recommends that Sorors send their reports directly to the individuals who need to receive them e.g. the Financial Team (Soror Shenise or Soror Melody) or Logistics (Soror Ursula); or, with the support of the Technology Team, to a centralized location.
- **Tea Roses:** Honors and Awards Committee (Soror Taitania) submissions of 15 awards applications/exhibits for SARC; Sisterly Relations (Soror Reneisha) for Sister Squads & Walk on Michelle Obama Trail on a chilly Saturday morning; Public Relations/Social Media (Soror Lynn) Highlighting Black History Month Moments; Connections and Social Action (Soror LaDonya) Hard work & AKA at the Capitol Awards Application/Entries.
- AKA Day at the Capitol: Luncheon moved from Sloppy Floyd Building to the Georgia Freight Depot. Soror LaDonya will share the name of the guest speaker.
- MAFD: There is prepaid parking for the event. Soror Lynn is planning a time and location before the luncheon to take a chapter photo for members who have paid to attend. Time and location will be published in *The Vine*. Everyone should arrive on time for the photo in order for us to transition on time into the luncheon. There will be vendors on site beginning at 8:00 a.m.
- 70th SARC: Registration is open. Soror Morgan, our Hodegos, has been asked to explore a location for a possible chapter luncheon in Orlando. Chapter is submitting 15 chapter awards; our undergraduate (Nu Alpha and Nu Beta) chapters are submitting a total of 7 awards. Chapters have the option to purchase an ad in the 70th SARC Souvenir Booklet. We don't have a line item budgeted for an ad. Soror YaTonya asked for "the pleasure" of the E-Board. Delegate certification due in March. In addition to the 5 officer delegates, the chapter will have the opportunity to nominate and elect the 7 additional delegates to attend SARC.
- Metro Basilei Council Meeting on 2/11: Discussed the courtesies to be extended to the VSGs across the Metro ATL chapters for Madam Regional Director, the Cluster V Coordinator and the Undergraduate Member-at-Large at MAFD. Chapter Basilei discussed forming a Budget and Finance Committees' cohort similar to the Metro ATL Basilei Council and the Anti-Basilei Council. This would be a quarterly event in connection with the Regional Tamiouchos. Spearheaded by the Basileus of Psi Alpha Omega. Details are forthcoming.

- Interest Group Process Information: Madam Regional Director has provided the Basilei with information regarding this process. Soror YaTonya has received another letter from an interest group requesting support from Lambda Epsilon Omega. Soror YaTonya read the letter to the E-Board from two City of Decatur and East Atlanta Sorors regarding forming an interest group for a new graduate chapter. The letter cited several rationales, individuals and entities who supported the formation of the new graduate chapter in that location. The authors of the letter, Soror Charnita West and Leslie Plunkett, indicated that the group was following the guidelines for interest groups as outlined in a manual provided by Madame Supreme Danette Anthony Reed. Soror YaTonya's input was sought. She indicated that she doesn't have an opinion because ultimately the decision will rest with Madame Supreme. Soror YaTonya did remind us of another letter of interest sent to Lambda Epsilon Omega for an Intown Atlanta Interest Group in an area which overlaps the City of Decatur and East Atlanta Interest Group's area. She indicated that one of the provisions of graduate chapters is that they not be formed within 30 miles of each other. Soror YaTonya gave the E-Board the opportunity to ask questions and make comments on the letter which requested our chapter's support. E-Board members provided various questions/comments. Concerns about the ability of general members to form a chapter, a duplication of services (our chapter is the county's chapter,) the motivation for forming the chapter and source of the request. After E-Board comments, Soror YaTonya requested that a motion be made by Soror Tonjua, who made a motion that that the chapter support the interest group's request. Soror Tamika H. seconded the motion. Additional discussion occurred. E-Board decided, based upon discussion after the motion, to withdraw the motion and not move forward with supporting the interest group.
- MAFD Ad : Soror YaTonya presented the cost for the chapter to purchase a SARC ad. Cost of ads: \$750 (full page), \$500 (1/2 page ad), \$350 (1/4 page ad). Listing of Chapter's Name: Platinum (\$250), Gold (\$150), Silver (\$75). This expense was a line item pre-pandemic; but our budget took on a different model in the pandemic. The E-Board voted to purchase the ½ page ad. Vote: Yes -20, No - 0, Abstain - 2

- **Empower Our Families:** Shopped and assembled 300+ CHIPP Bags. Distributed CHIPP bags to students at Oak View Elementary. There are enough powerpacks to last until mid-April. TBA: A packing session date on a Saturday in April. A female volunteer, Debbie Jones (owner of a catering and food truck company) is purchasing and packing the same powerpacks that the chapter is distributing. She started distributing her monthly packs at the end of January.
- **Mental Health Awareness:** Has been posting mental health tips in *The Vine* once a week.
- **Youth Leadership Institute:** Will meet on 2/26 at 2:00 p.m. at West Trinity Place in Decatur. Committee is currently putting together leadership packets for students ages 11-16.
- **Strengthening Our Sisterhood:** The Book Club Squad held their 1st meeting on February 7th @ 7:00p.m. The meeting was facilitated by Soror Corinne Cooper. Next meeting will be February 28th @ 7:00 p.m. The Book Club Squad will discuss the book Black Cake by Charmaine Wilkerson. The info is in *The Vine*. - Committee would like info on the emergency preparedness plan and floor plans at the new meeting facility. Would like the name of a contact person at that facility to get on the same page regarding that information.
- Wants to collaborate with Protocol who puts out the conference safety guide. Would like to include the Risk Management info in that guide so that there are not several different guides/documents floating around; it would all be in one document. Soror YaTonya remarked that the collaborations mentioned by Soror Tamika are a great idea. Requested that she email Soror YaTonya and Soror Ursula the information she needs from St. Philip so that they can obtain the information from the appropriate person at that location.
- Will not need any time to present at chapter meeting because the committee is currently trying to develop a plan for creating a secure and accessible location for storing the sensitive information that will be collected from chapter members.

- Our chapter has achieved Platinum Status, again. A check for \$3,320.95 was mailed to Corporate in January. The chapter will be recognized at SARC in April.
- At the EAF Cluster meeting, it was announced that a new Platinum Status formula was being instituted based on the number of chapter members. Although our chapter had instituted a \$6.00 EAF donation by each member, with the new Platinum guidelines, the \$6.00 amount per member will not enable us to meet the requirement for Platinum Status moving forward. The committee discussed creative ways to come up with the additional funds.
- Soror YaTonya and Soror Carmen will meet off-line to discuss a way to address the deficit. Soror YaTonya proposed making the appeal to the chapter. Soror Luevenia suggested including members of the Financial Team in the conversation because of logistics especially since Sorors have already made a payment of \$6.00. Soror YaTonya suggested having a focus group to discuss the logistics.

Connections and Social Action: Soror LaDonya presented the report.

- Committee met and developed its 6 month plan and established co-leaders for several of the major projects.
- AKA Day at the Capitol is 2/19 Virtual and 2/20 Virtual or In-person (sold out.) Virtual deadline registration is 2/17. 300+ have registered to attend in person and 700+ virtually. Donations were solicited from members of the chapter to pay the registration fee for undergraduate members. Thank you to Sorors Kenyatta Stephens, Onetisha Anderson and Cynthia Tate who donated; so, we are sponsoring undergraduates to attend AKA Day at the Capitol. Guest speaker will be 1st Supreme Anti-Basileus Charletta Wilson Jacks. The committee submitted an award application for the Most Innovative and Collaborative Award/Recognition and for the Attendance Award.
- High School Voter Recognition Activities: 2/2 Arabia Mountain HS (9 registered); 2/9 Stone Mountain HS (32 registered); 2/15 Towers HS (registered 15.) Upcoming: 2/21 Lithonia HS and 2/28 Tucker HS.

Bylaws: Soror LaMia Saxby – No report.

Audit: Soror Shelene Thompson presented the report.

- Update on the hand-off of the financial records to the then retained CPA Tim Brown that would subsequently lead to a presentation to the E-Board in April and chapter members in May. Mr. Brown's retainer fee exceeds the amount budgeted by the chapter. The chapter has been seeking to retain a new CPA for services; however, no one has confirmed. Soror Shelene made a motion for the E-Board to accept

Soror Shelene was instructed to prepare the motion and give it to Soror Phyllis to read after the approval of the chapter meeting minutes.

Soror YaTonya asked if we have a projector in our storage unit. Soror Wanda indicated that Technology has the projector. 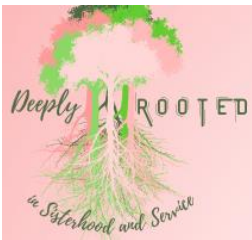
